Regular Board of Education Meeting Wednesday, September 21, 2016, at 6:00 p.m. Board of Education Room at Durand Middle/High School

Meeting Called to Order

Board President, Mr. Yingst, called the meeting to order at 6:00 p.m.

Mr. Doverspike stated that the meeting was properly noticed in all of the regular places per Board policy.

Business

a. Approval of bid for Site Work for New Garage

Three bids were received for the site work of the new garage at the Durand Middle/High School. Motion made by Mrs. Richardson and seconded by Mr. Hoch to accept the bid from RM Schlosser for \$25,560. Motion carried by a unanimous voice vote.

b. Approval of bid for Construction for New Garage

Three bids were received for the construction of the new garage at the Durand Middle/High School. Motion made by Mrs. Richardson and seconded by Mrs. Hoyt to accept the bid from Johnson Construction for \$134,543.69. Motion carried by a unanimous voice vote.

c. <u>Discussion on official name of Co-Curricular Groups and Extra-Curricular Teams</u>

There has been some confusion after the approval to change the school district name last month as to whether we are the Durand Panthers or the Durand-Arkansaw Panthers. Motion made by Mrs. Richardson and seconded by Mrs. Hoyt to leave the name the way it is (Durand Panthers). Motion carried by a majority roll call vote. Bauer, Hoch, Hoyt, Martin, and Richardson voted yes and Weisenbeck and Yingst voted no.

- a. Greg Doverspike, District Administrator
 - i. Construction Update

Construction is finished, however, there is a little HVAC work to do and a couple other things to finish.

ii. 2016-2017 Budget

Based on an estimate of our equalization aid, we will have a balanced budget for 2016-17. On paper it looks like we have a deficit, however, we carried over some funds from the 2015-16 budget that will wipe out the deficit.

iii. 2016-2017 Preliminary Enrollment

A preliminary look at our 3rd Friday pupil count is that we are up 7 in seat count but down 1.6 FTE. The open enrollment gap has closed slightly from last year with a few less students transferred out and a few more that have transferred in.

iv. Building Dedication Plan

The building dedications for both Caddie Woodlawn and Durand Middle/High School will be similar but John Ashley, WASB Director, will only be at Caddie. Senator Kathleen Vinehout and Representative Warren Petryk will present both a U.S. flag and a Wisconsin flag at each building.

v. Athletic Department Golf Outing

The 10th annual golf outing was successful, however, not all figures are in yet to know how much money was raised. The golf course did a great job hosting the event and Todd Poeschel did a tremendous job organizing and running the event. Proceeds from the golf outing will be used to purchase new equipment for the weight room.

vi. Surplus Property Thrift Sale

There will be a surplus property sale at Arkansaw Elementary on Saturday from 9:00 a.m. to 1:00 p.m. There are file cabinets, carts, shelves, desks, chairs, etc. all priced to sell.
